DM Reports: DM Perrin reported on the April sales, burials, safety meeting, major purchases and attendance.

DF Report: DF Barron said that things are coming along with the Memorial Day. It has been difficult to find reliable people from IMKO who want to work.

Incident Report: Per the emails dated April 30th and May 2nd, the Lay Linh Saechao marker has not been hit by any equipment and the original setting of the marker was not done properly. Investment Committee Report: Trustee Flood said everything is in order and would like to set a date and time to meet with Sandra Wheeler, our Wells Fargo Investment advisor.

Margaret Anne Lowery Jasso-Letter to Trustees: After some discussion and guidance from our District Counsel, Trustee Vogel motioned to accept the letter from Margaret Anne Lowery Jasso, to be buried in this cemetery, pursuant to the contract dated August 24, 2004 and was seconded by Trustee Clouse. The motion passed 3 0-1 Nay (Dodds).

Mark Marshall of GSRMA: The reason for the attendance of Mark Marshall from GRMA was that we had sent a notice of withdrawal last year. He cited the benefits of staying with GSRMA. First, the rates have come down approximately \$1800.00, in the past 6 years we have received \$14,757.00 in rebates, and for 2018 we should receive a rebate of \$2790.00. Trustee Flood motioned to continue with GSRMA and was seconded by Trustee Vogel. The motion passed 4-0. DM Perrin was instructed to write a letter to remain with GSRMA for FY 2018-2019.

Approval of Claims: Trustee Flood motioned to approve the claims and was seconded by Trustee Vogel. The motion passed 4-0.

Approval of Changes in FOCD Employee Handbook: Trustee Flood had more changes to be made to the handbook. District's Counsel, Bob Hunt, said he would make those changes and have it ready for the June meeting. Also, the Desk Reference needs to be done which describes task procedures.

Approval of Fraud Policy: After review, Trustee Flood motioned to approve the Fraud Policy and was seconded by Trustee Vogel. The motion passed 4-0.

Selection of RDAOB Representative: Trustee Flood motioned to vote for Amanda Thomas and was seconded by Trustee Vogel. The motion passed 4-0.

Selection of RDAOB Alternate Representative: Chairman Clouse motioned to vote for Jeff Frye and was seconded by Trustee Dodds. The motion passed 4-0.
