Call to Order: Chairman Clouse called the meeting to order at 9:15a.m.and those assembled recited the Pledge of Allegiance.

DM Young noted the bullet points regarding the creation of a JPA (Joint Powers Authority) for Cemetery Districts only, which we would then be in control of our own destiny. If the Districts are going to pursue forming their own JPA, a letter of withdrawal needs to be submitted to GSRMA. Per their policy, a 12-month notice is required. Trustee Flood motioned to produce a withdrawal letter to GSRMA, with the understanding that we can withdraw our withdrawal letter. Trustee Vogel seconded and the motion passed 5-0. Per OSHA's recommendations on the Heat Illness Prevention, the Policy & Procedure committee will address the changes following the adoption in June. DM Young mentioned that Daneece Frazier (owner of EJ's Little People) has an autistic son whom she would like do volunteer work in the cemetery. His name is Ian and he is capable of doing jobs, such as cleanup work in the cemetery. DM Young would like to have him do some work on a trial basis. Trustee Vogel motioned to allow Ian Frazier to do volunteer work, with the approval of GSRMA's release to work and to run it past our legal counsel, Bob Hunt. Trustee Dodds seconded and the motion passed 5-0.
